Further to the disclosures made by Century Properties Group Inc. ("CPGI") relative to the case against the Okada Group, CPGI would like to inform the Honorable Commission and the Honorable Exchange that the Company was notified by its legal counsel today, April 23, 2015, of a Court Order issued by the Court Of Appeals dated March 27, 2015 granting Okada's Petition for Review, thus setting aside the Court Order dated July 25, 2014 issued by the Regional Trial Court of Makati, Branch 66 which ordered in favor of Century Properties Group. Inc.'s ("CPGI") the preliminary prohibitory injunction against the Okada. CPGI's counsels are now studying the legal options the Company will take anent to this order.
