Further to the disclosures made by Century Properties Group Inc. (“CPGI”) on 1 April 2014, in connection with the Petition for Interim Measures of Protection filed on 31 March 2014 against the Okada Group and docketed as Civil Case No. 14-359 before the Regional Trial Court, Makati City, Branch 66 (the “Court”), and the Order issued by the Court on 1 April 2014 granting the application by CPGI for the issuance of an immediately executory 20-day Temporary Order of Protection, as well as the disclosures made by CPGI on 30 April 2014, in connection with the Order dated 23 April 2014 extending the Temporary Order of Protection for another 20 days, CPGI hereby discloses we have been notified by our legal counsel that the Court issued an Order dated 13 May 2014 (the “Order”), denying and dismissing the Petition for Interim Measures of Protection. As of date, CPGI is studying its legal options concerning their transaction with the Okada Group.

CPGI further undertakes that it shall inform the Honorable Exchange with regard to other material information relative to these transactions.
