Century Properties Group sells P2B vacation homes in Batulao Artscapes project

[October 2018] Century Properties Group (CPG:PM), through its leisure, tourism and hospitality business unit has announced that it has pre-sold 342 vacation homes worth P2 billion in Batulao Artscapes, its first residential tourism project in Nasugbu, Batangas.

When the 49-kilometer Cavite-Tagaytay-Batangas Expressway (CTBEX) is completed in mid-2022, travel time to nearby Tagaytay City will only take less than an hour.
