  - (a) THIRD: That the place where the principal office of the corporation, is to be located shall be at the 21/F Pacific Star Building, Sen. Gil Puyat corner Makati Avenue, Makati City, but it may establish branches in some foreign countries.
  - (b) ARTICLE I Office The principal office of the Corporation shall be located at the 21st Floor, Pacific Star Building, Sen Gil Puyat Avenue corner Makati Avenue, Metro Manila, Philippines. The Corporation may have offices at such other places of business in the Philippines or in foreign countries as the Board may, from time to time, designate.
